- I Ceffilions

 1.1 "Seller' shall mean Fastlands Pty Ltd TI/A Cardboard Box Shop and its successors and assigns.

 1.2 "Buyer" shall mean the buyer or any person or Seller acting on behalf of and with the authority of the buyer.

 1.3 "Guarantor" means that person of or persons), or retry who agrees herein to be liable for the debts of the Buyer if a Limited Liability Buyer on a principal debtor basis.

 1.4 "Goods" shall mean Goods supplied by the Seller to the Buyer (and where the context so permits shall include any supply of Services as hereinafter defined).

 1.5 "Services" shall mean all services supplied by the Seller to the Buyer and includes any advice or recommendations (and where the context so permits shall include any supply of Goods as defined supra).

 1.6 "Price" shall mean the cost of the goods as agreed between the Seller and the Buyer subject to clause 4 of this contract.

- 2. Acceptance
 2.1 Any instructions received by the Seller from the Buyer for the supply of Goods and/or the Buyer's acceptance of Good and/or Sensitives supplied by the Seller shall constitute acceptance of the terms and conditions contained herein.
- anoun services suppred by the select shall not distulbe acceptance or the terms and conditions contained interior. 2.2 Upon acceptance of these terms and conditions by the Buyer the terms and conditions are irrevocable and can only be rescribed in accordance with these terms and conditions or with the written consent of the manager of the Seler 2.3 None of the Seler's agents or representatives are authorised to make any representations, statements, conditions or agreements not expressed by the manager of the Seller in writing nor is the Seller bound by any such unauthorised statements.

- 3. Goods
 3.1 The Goods shall be as described on the invoices, quotation, work authorisation, sales order or any other work commencement forms as provided by the Seller to the Buyer.
 3.2 The Buyer shall take delivery of the Goods tendered notwithstanding that the quantity so delivered shall be either greater or less than the quantity purchased provided that;
 (a) such discrepancy in quantity shall not exceed 20%
 (b) the Price shall be adjusted pro rata to the discrepancy.

- 4. File A flor Faying.

 4.1 At the Sellers sole discretion;

 (a) The Price shall be as indicated on invoices provided by the Seller to the Buyer in respect of Goods supplied; or

 (b) The Price shall be the Seller's current price at the date of delivery of the Goods according to the Sellers current Price list
- or (c) The price of the Goods shall be the Seller's quoted Price which shall be binding upon the Seller provided that the Buyer

 4.6 Payment will be made by cash on delivery, or by cheque, or by bank cheque, or by credit card, or by direct credit or by any other method as agreed to between the Buyer and the Seller.

 4.7 The Price shalb be increased by the amount of any GST and other taxes and dufies which may be applicable, except to the extent that such taxes are expressly included in any quotation given by the Seller.

- 5. Delivery Of Goods
 5.1 Delivery of Goods shall be made at the Buyers address. The Buyer shall make all arrangements necessary to take delivery of Goods whenever they are tendered for delivery or delivery may be made at the Buyers address or delivery shall be made at the Selfer's Address.
 5.2 Delivery of the Goods to a carrier, either named by the Buyer or failing such naming to a carrier at the discretion of the Selfer for the purpose of transmission to the Buyer, is deemed to be a delivery of the Goods to the Buyer.
 5.3 The costs of carriage and any insurance which the Buyer reasonably directs the Selfer to incur shall be reimbursed by the Buyer (without any sel-off or other withholding whatever) and shall be deemed to be the Buyer's agent.
 5.4 Where there is no agreement that the Selfer shall send the Goods to the Buyer, delivery to a carrier at limited carrier's risk at the expresse of the Buyer is deemed to he delivery to the Buyer.
- 5.4 Where there is no agreement that the Seller shall send the Goods to the Buyer, delivery to a carrier at Imitted carrier's next at the expense of the Buyer is deemed to be delivery to the Buyer.
 5.5 Delivery of the Goods to a third person, named by the Buyer, is deemed to be a delivery of the Goods to the Buyer.
 5.6 The Seller may deliver the Goods by separate installments (in accordance with the agreed delivery schedule). Each separate installment shall be invoiced and paid for in accordance with the provisions in this contract of selle.
 5.7 The failure of the Seller to deliver shall not entitle either party to treat this contract as repudiated.
 5.6 The Seller shall not be liable for any loss or dramage whatever due to failure by the Seller to deliver the Goods (or any of

- 6. Risk
 6.1 If the Seller relains property in the Goods nonetheless all risk for the Goods passes to the Buyer on delivery.
 6.2 If any of the Goods are damaged or destroyed prior to property in them passing to the Buyer, the Seller is entitled, without prejudice to any of its other rights or remedies under these terms and conditions (including the right to receive payment of the balance of the Price for the Goods), to receive all insurance proceeds payable in respect of the Goods. This applies whether or not the Price has become payable under these terms and conditions. The production of these terms and conditions by the Seller is sufficient evidence of the Seller's sights to receive the insurance proceeds as follows:
 (i) first, in payment of the Price of the Goods that are damaged or destroyed, if unpaid;
 (ii) second, in payment of the outstanding Price of any other Goods supplied to the Buyer by the Seller whether under the terms and conditions or otherwise.

 (iii) third, in payment of any other sums payable to the Seller by the Buyer on any account

 (iv) fourth, any balance is to be paid to the Buyer.

7. Defects
7.1 The Buyer shall inspect the Goods on delivery and shall within seven (7) days of delivery notify the Seller of any alleged defect, shortage in quantity, damage or failure to comply with the description or quote. The Buyer shall afford the Seller an opportunity to inspect the Goods within a reasonable time following delivery if the Buyer believes the Goods are defective in any way. If the Buyer shall fail to comply with these provisions the Goods shall be conclusively presumed to be inaccordance

8. Return Of Goods

- 8.1 For defective Goods which the Seller has agreed in writing that the Buyer is entitled to reject, the Seller's liability is limited 8.1 For detective Goods winch the Seller has agreed in writing that the suyer is entitied to reject, the Seller's discretion replacing the Goods or repairing the Goods provided that:
 (a) the Buyer has complied with the provisions of clause 7.1;
 (b) the Goods are returned within seven (7) days of the delivery date;
 (c) the Seller will not be liable for Goods which have not been streed or used in a proper manner;
 (d) the Goods are returned with some winch that we not been streed and with all packaging material, brochures and instruction material in as new condition in which they were delivered and with all packaging material, brochures and instruction material in as new condition as is reasonable possible in the circumstances.

- 9. Warranty
 9.1 For Goods not manufactured by the Seller the warranty shall be the current warranty provided by the manufacturer of the Goods. The Seller shall be under no liability whatsoever except for the express conditions as detailed and stipulated in the manufacturers warranty.

 9.2 The Seller does not undertake that repair facilities and parts will be available for the Goods and will not be liable to repair any defective Goods and at its own discretion may.

 (a) notify the manufacturers of the Goods of any defect notified by the Buyer; and
 (b) request the manufacturers for perair or replace any defective Goods.

 9.3 In respect of all claims the Seller shall not be liable to compensate the Buyer for any delay in either replacing or repairing the Goods or in mornely assession the Buyers relain.

10. The Commonwealth Trade Practices Act 1974 and Fair Trading Acts

10.1 Nothing in this agreement is intended to have the affect of contracting out of any applicable provisions of the Commonwealth Trade Practices Act 1974 or the Fair Trading Acts in each of the States and Territories of Australia, except to the extent permitted by those Acts where applicable.

- 11. Buyers Disclaimer / Cancellation
 11.1 The Buyer hereby disclaims any right to rescind, or cancel the contract or to sue for damages or to claim restitution arising out of any misrepresentation made to him by any servant or agent of the Seller.
 11.2 The Seller may cancel these terms and conditions or cancel delivere of Goods at any time before the Goods are delivered by giving written notice. The Seller shall not be liable for any loss or damage whatever arising from such concellation.

- 12. Default & Consequences Of Default
 12.1 Interest on overdue invoices shall accrue from the date when payment becomes due daily until the date of payment at a ratle of 2.5% per calendar month and shall accrue at such a rate after as well as before any judgement.
 12.2 If the Buyer defaults in payment of any invoice when due, the Buyer shall indemnify the Seller from and against all the Seller's costs and disbursements including on a solicitor and own client basis and in addition all of EC Credit Control Pty Ltd's
- costs of collection. 12.3 Without prejudice to any other remedies the Seller may have, if at any time the Buyer is in breach of any obligation

 13. It is the inlention of the Seller and agreed by the Buyer that property in the Goods shall not pass until:

 (a) The Buyer has paid all amounts owing for the particular Goods; and

 (b) The Buyer has met all other obligations due by the Buyer to the Seller in respect of all contracts between the Seller and the Buyer, and that the Goods, or proceeds of the sale of the Goods, shall be kept separate until the Seller shall have received payment and all other obligations of the Buyer are met.
- 13.2 it is further agreed that:

 (a) The Buyer shall not deal with the money of the Seller in any way which may be adverse to the Seller.

 (b) Until such time as ownership of the Goods shall pass from the Seller to the Buyer the Seller may give notice in writing to the Buyer to return the Goods or any of them to the Seller. Upon such notice the rights of the Buyer to obtain ownership or any other interest in the Goods shall cease.
 (c) If the Buyer fails to return the Goods to the Seller then the Seller or the Seller's agent may enter upon and into land and

 (a) Where the Buyer and/or the Guarantor (if any) is the owner of land, realty or any other asset capable of being drandor specal mortgage and/or charge all of their joint and/or several interest in the said land, realty or any other asset to the Seller or the Seller's nominee to secure all amounts and other monetary obligations payable under the terms and conditions. The Buyer and/or the Guarantor acknowledge and agree that the Seller (or the Seller's nominee) shall be entitled to lodge where appropriate a caveat, which caveat shall be released once all payments and other monetary obligations payable hereunder have been met.
 (b) Should the Seller selled to proceed in any manner in accordance with this clause and/or its sub-clauses, the Buyer and/or Guarantor shall indemnify the seller from and against all the Seller's costs and disbursements including legal costs on a socilior and own client basis.

 15.2 The Buyer and/or the Guarantor/s agree that the Seller may exchange information about Buyer and Guarantor/s with those credit providers named in the Application for Credit account or named in a consumer credit report issued by a reporting agency for the following purposes:
 (a) To assess an application by Buyer.
 (b) To notify their credit providers of a default by the Buyer;
 (c) To exchange information with other credit providers; as to the status of this credit account, where the Buyer is in default with other credit providers; and (d) To assess the credit worthiness of Buyer and/or Guarantor/s.
 15.3 The Buyer consents to the Seller being given a consumer credit report to collect overdue payment on commercial credit

 15.4 The Buyer agrees that Personal Data provided may be used and retained by the Seller for the following purposes and for
- other purposes as shall be agreed between the Buyer and Seller or required by law from time to time (a) provision of Goods & Services:

- (a) provision of Goods & Gervices; (b) marketing of Goods and or Services by the Seller, its agents or distributors in relation to the Goods and Services; (c) analysing, verifying and/or checking the Buyer's credit, payment and/or status in relation to provision of Goods/Services; (d) processing of any payment instructions, direct debt ficatilities and/or credit facilities requested by Buyer, and (e) enabling the daily operation of Buyer's account and/or the collection of amounts outstanding in the Buyer's account in relation to the Goods and Services.

 15.5 The Seller may give, information about the Buyer to a credit reporting agency for the following purposes: (a) to othat an aconsumer credit freport about the Buyer; and or (b) allow the credit reporting agency to create or maintain a credit information file containing information about the Buyer.

- 16. Lien & Stoppage in Transit
 16.1 Where the seller has not received or been tendered the whole of the price, or the payment has been dishonoured, the
 seller shall have:
 (a) a lien on the goods;
 (b) the right to retain them for the price while the seller is in possession of them;
 (c) a right of stopping the goods in transit whether or not delivery has been made or ownership has passed; and
 (d) a right of ressele.

- (e) the foregoing right of disposal, provided that the lien of the seller shall continue despite the commencement of proceedings or judgement for the price having been obtained.
